Call to Order

Mr. Vaughan called the meeting to order at 2:50 p.m. after holding an Executive Session on internal matters at 2:30 p.m.

Approval of Minutes

Mr. Rost made a motion to approve the minutes from the meeting of November 15, 2016. Mr. McColgan seconded the motion. The motion passed 5-0.

Executive Director's Report

Mr. Rice welcomed PICA's newest staff member, Konstantinos Tsakos.

Mr. Rice reminded the Board that during next month's Board meeting, the city Managing Director will be present to discuss overtime and related challenges with members. Mr. Karp requested looking into overtime usage of Police with respect to court attendance; meeting with the courts, Police and DA's office on the subject; and potentially commissioning a study on how to lower these costs. Mr. Vaughan agreed this was a good topic to research and expressed a willingness to meet with those departments to get more information.

New Business

Mr. Vaughan noted that the Philadelphia Court of Common Pleas dismissed the law suit on the sweetened beverage tax today. Mr. Kessler stated that the Board should invite the City Solicitor to a Board meeting to discuss the next step once an appeal is filed. Mr. Vaughan agreed and said he would circulate the decision to the Board members.
