Mr. Vaughan called the meeting to order at 1:05 p.m.

PICA staff will be releasing the August tax revenue report tomorrow. Mr. Rice added that PICA's FY2023 audit is on-target for the City to receive the completed report by September 30th. The MD&A has been finalized, and the financial statements should be sent to the City tomorrow.

Mr. Rice announced PICA's fall conference will be held on November 8th, from 10:00 am to 12:00 pm. The topic of the conference is climate change and its impact on the City of Philadelphia. Presenters include Steve Mullin, Econsult; Elizabeth Lankenau, the City's Director of the Office of Sustainability; and Dr. Franco Montalto, Professor of Engineering with Drexel University.
