WHEREAS, the Authority has received a proposal from Maher Duessel, dated April 21, 2017 (the "Proposal"), to provide the Auditing Services for the Authority for the fiscal year ending June 30, 2017, with two, one-year renewal options, a copy of which Proposal is attached hereto as Exhibit "A"; and

WHEREAS, the board of the Authority desires to authorize the engagement of Maher Duessel to provide the Auditing Services in accordance with the Proposal;

NOW THEREFORE, BE IT RESOLVED:

- 1. The board of the Authority hereby approves the appointment and engagement of Maher Duessel to provide the Auditing Services for the Authority for the fiscal year ending June 30, 2017, with two, one-year renewal options, in accordance with, and upon the terms and conditions set forth in, the Proposal, and hereby authorizes the acceptance of the Proposal by the Authority.
- 2. The proper officers of the Authority are hereby authorized to prepare, execute, deliver and file any and all documents, instruments, agreements, certificates and other papers of any kind whatsoever, and to do any and all other acts or things, that are necessary or appropriate in order to carry out the intent and purposes of this Resolution.
- 3. The Authority hereby ratifies and confirms any and all prior actions taken by or on behalf of the Authority consistent with the intent of this Resolution.

4. All prior resolutions or parts of prior resolutions not in accordance with this Resolution are hereby repealed insofar as they conflict herewith.
